## AMERICA'S FIRST FREEDOM: Part II

Is there any question that we are presently in the middle of a world conflict unlike any we have seen before? We seem to be witnessing a competition on the world stage, not only for our bodies, but more importantly, for the hearts and minds of all the souls on earth. It seems obvious that there are forces who have controlled the world and its economic system for many, many years.

Over the last couple of years, while finishing our first book, *America's First Freedom*, it became clear to me that everything, not just *some* of things, but almost *everything* we have been taught through our history books and classrooms is almost 180 degrees different from what really happened.

Events, people, and ideas have been suppressed, distorted, and purposely twisted – to keep all of us divided, confused, and ignorant about who we really are, what our rights really are, and what our history has really been. This has been done to *control* us, and those who are our controllers have done an amazing job!

One thing I've learned (and relearned) through the years, that I now think is a vital principle for living: *the mind, like a parachute, works best when open!* During the process of opening my mind and remaining open, some of my most closely held beliefs have been challenged. It has been hard. It sometimes literally was painful . It has at times made me ache and feel rudderless. I have learned to breathe deeper and trust that *knowledge—truth—can't hurt me*. It is false or fake knowledge that hurts. Fake news, untruths, cover-ups, deceptions, and falsehoods are what hurt us most of all!

## The First Amendment in the Era of COVID

In our previous book, *America's First Freedom*, we delved into the guarantees of the First Amendment, most specifically freedom of religion, particularly as it applied to us in the 1980's. But the First Amendment covers more than just the freedom of religion. It guarantees the following.

- Freedom of religion; forbids prohibiting the free exercise thereof
- Freedom of speech
- Freedom of the press
- The right to peaceful assembly
- The right to petition the government for redress of grievances

There is a lot of power in those five points. In our recent lifetimes, more poignantly during the COVID years, we've seen these precious rights – rights that we were born with – eroded, mocked, and ignored in our daily lives.

We have seen recently how the state-mandated lockdowns literally forced churches to close their doors under the premise that crowds of people coming together, singing, praying, rejoicing, and maybe even hugging would be a serious danger to our communities. History and time will tell whether this was necessary, helpful, or actually harmful. But it demonstrates the power the state wields to ignore and break the First Amendment when it is deemed necessary, leading us to believe it is for our own good.

The First Amendment warns the government to *not abridge the freedom of speech*. We don't use that word "abridge" much in our conversations today, and when we do use it we generally mean "to abbreviate, condense, or shorten." A modern

dictionary defines *to abridge*: an “archaic law,” meaning to *deprive privileges and rights*. The word used in context of the Continental Congress when creating the Bill of Rights was a warning from our founding fathers of the propensity of governments to deprive people of their inalienable rights.

Solidifying during the COVID years, freedom to speak freely what’s on one’s mind has become taboo in many of our main methods of communication. Social media has today replaced many of the former methods of interacting and sharing information with each other. Social media magnates have appointed themselves the *gate-keepers* of what should be individual expression by marginalizing, restricting, redacting, or totally blocking what free Americans are allowed to say on their platforms. In the beginning, these platforms promised free, fair, and uncensored ways to post one’s viewpoint. What changed?

After years of gradually changing this stance, they now ban, block, or remove anyone who doesn’t agree with their particular narrative. Our government stands by passively, allowing and even encouraging this behavior by big tech. Recent revelations suggest that weekly meetings were held between government and tech officials to decide what to allow on the platforms—what the general public could read and hear about.

During COVID, the network news stations all reported in lockstep the narrative provided to them – to play up the danger of the virus and its spread – and never hinted at other viewpoints that might be just as valid as, maybe even more valid than, what we were told. Vaccines that had been rushed to market, deprived of years of careful scientific testing and observation of results, were touted as being safe and effective, and if sixty-five percent of the population would get the shot,

the pandemic would be stopped in its tracks, and we could all quit wearing masks and go back about our lives.

But the narrative started changing almost immediately. We now needed to take a second shot before all would be well . . . and now we need to take a booster shot before all will be well . . . and now we need a booster every few months before all can be well . . . kind of like crying “wolf!” over and over again with a hypodermic voice. No news platform encouraged people to boost their immune systems via fruit-and-vegetable-rich nutrition, reducing intake of sugars and carbs, supplying sound supplementation with pertinent vitamins, and dramatically increasing physical activity.

Did we really have freedom of press in America through the COVID era? If you have kept up with current Tweets (February/March 2023) from Elon Musk, you may have noted many related to government suppression of the real story behind many issues, including Tony Fauci and COVID-19.

The unparalleled heavy-handedness used during the pandemic of 2020-2022 (or as I’ve come to suspect, a *Plandemic*?) in the US produced lockdowns restricting peaceful assembly and worship. Many of our churches unknowingly participated in what contributed to additional erosion of First Amendment rights. Never before have free Americans been told to stay home, except for essential travel for food or work. While hundreds or thousands of small businesses and restaurants were shuttered, many never to reopen, the powers that be allowed big box conglomerates to remain open, to thrive and prosper during these mandated lockdowns.



The COVID era spawned at least two major, emotionally charged “assemblies,” that occurred in spite of the restrictions of lockdown. Political parties who infest our government were eager to let some groups riot, destroy, burn, steal, and pillage without reprisal, as we saw during the summer of 2020. Yet other groups, of opposing political perspectives, had unprecedented action taken against them for protesting at the Capitol in early 2021. Stories abound online of some of those who were arrested, held in deplorable conditions of jail cells, beaten, and denied normal legal rights. While anyone who, indeed, broke a law in either scenario deserves a just and reasonable punishment, *we are not seeing equal application of the law to all offenders*. Hopefully, history and time will reveal the true story.

I recently was struck by an important distinction regarding “Assembly.” I used to think of it mainly in a religious context – people assembling to worship. The idea of our forefathers didn’t stop with only this, however. They envisioned that within the various states, communities, towns, and villages (in other words, *locally*) the people would assemble *to monitor the activities of the governments* of these communities.

By coming together in assembly, *we*, as concerned and thoughtful Americans, *can participate in designing, building, and protecting the kinds of local communities in which we choose to live*. And by such participation we can keep an eye on what is going on – to limit corruption and the promotion of personal agendas and to demand accountability of those we elect or appoint to serve our needs.

To arrive at relevant decisions, people need to assemble in small local groups to exchange ideas, viewpoints, and have discussion about our home communities. *This is written into and implied in our basic freedoms and rights as Americans!*

Through this avenue we have a huge role to play and a huge responsibility. By locking down the population, free discussion, perhaps about the pandemic in general, was thwarted, very possibly sparking eventual eruptions of frustration and repressed emotions.

Right along with that right and responsibility comes the right to petition for a redress of grievances. What the heck is *redress of grievances*? Although this term also isn't commonly used today, it hasn't really morphed in meaning over time. It means *to set right or rectify an undesirable situation, to make amends, or to satisfy a wrong or injury*.

Most Americans are busy with day-to-day living, trying to make ends meet, especially now with inflation running wild. Most of us don't take seriously or think we have time for participation and involvement in local and state oversight. Yet how critically important is our part in our government process! It is much more than just showing up to vote every 2-4 years. If we don't do our part and participate, how can we justify complaining (expressing grievances) about what is going on around us? It's not that we don't have grievances, because we have them in abundance. So, then, what is it?

Much of it is simply not knowing what we can do. Some of it is using the excuse of being too busy to spend time on local issues. More of it is not knowing what our rights provide for or expect us to do. Tragically, our children are no longer taught in school about our Constitutional rights. We spend our time after work trying to have a bit of fun, whether in watering holes, sporting events, movies, or in front of our televisions and computers and smart phones. We are content to let others do the thinking for us, letting others tell us what we should think and what we should

do and what we should say – instead of figuring it out for ourselves. And we wonder why we are frustrated and uneasy about our world!

In free assembly, issues can be confronted and discussed. Free assembly is the vehicle whereby we come together to decide whether a petition to redress a grievance is an appropriate action to take. We all experienced this right being flagrantly repressed during the lockdowns, even if we were not fully aware of what was subverted.

*Taken collectively, ignoring and repressing all aspects of our First Amendment freedoms during the pandemic represent the most recent and egregious insult to the American people's Constitutional rights.* Other populations around the world experienced similar suppression of human rights during this global event.

On the other hand, if control of the people *were*, indeed, the goal, how *would* one most effectively proceed? First, create something to fear that is big enough that people will listen. Next, keep people at home. Don't let them meet in churches, taverns, and street corners where they might discuss whether they think the fearful threat is real or not. Tell them they must stay at least six feet apart from each other when they do go out for essential food or medical care.

Mandate everyone wear face masks to cover their mouth and nose, thereby covering most of the facial expressions. Body language and especially facial expressions are considered to be 55% of our communication (7% being the actual words and 38% how the words are used). At the beginning of the pandemic it was scientifically supported that masks were not substantially effective in blocking the virus. Then it changed as the official narrative.

Furthermore, appeal to their altruism by telling them if they don't follow the guidelines, they will endanger old people (grandparents), children, and those with compromised circumstances. Feed the frightened people with 24/7 news-outlet-repetition of the seriousness of the threat and how everyone must behave in order to minimize its spread. Tell the people that the "authorities" are the only ones who know the correct answers to the problem. Squelch any dissident outcry by marginalizing, ridiculing, and criminalizing the dissident.

The main news narrative presented to the public was certainly *not* that COVID was a premeditated device for gaining control of the people, however, if it were I who wanted widespread control, I would go about it pretty much exactly as things played out during the pandemic. I also happen to believe that the four most potent tools for creating fear and gaining control *down through history* have been "in the name of God and church," "for the greater good," "for public safety," and "in the name of national security." Let your own common sense lead you to your own conclusions here. But *do* think about it! "*Not thinking*" by the people is one of the most valuable assets of those who want to stay in power.

At this point, let's turn to some of the events in our American history that are overlooked, hidden or mistakenly reported.

## **The British Accreditation Registry, Lincoln, the 13<sup>th</sup> Amendment, and Admiralty Law**

The erosion of our Constitutional rights isn't new. It's been going on since long before the arrival of COVID-19. If you have read *America's First Freedom*, you may recall that powerful and wealthy merchant and banking families have sought to control the entire world for many hundreds, and possibly thousands, of years. This control has been based primarily on financial concerns. The formation of a new nation in America became a serious threat to those seeking control. The precepts of freedom being espoused and established by an upstart bunch of rebels had to be stopped. They needed to be controlled at all costs. Those seeking control made a plan and said among themselves, "Let them think they are free, while little by little we will tighten the screws." Kind of like turning the heat up under the pot with a frog, as described in *America's First Freedom*.

What I want to bring to your attention in current context is the hidden history that London, the royal family, and powerful European families have been the long-time controllers of the purse strings of the world. Commerce of the British Empire was spreading to every corner of the globe. The king of England did not take kindly to the rebellious colonies in America. He also knew how expensive wars are. He knew that struggling new governments, like the newly-born United States, need money to keep going after expensive wars.

Although history, as available to us today, is suspiciously quiet on how all this began and has played out, deep research indicates that the king of England actually declared a truce, unbelievable as it seems. Instead of total defeat, he set up a system whereby the colonies would think they had won, but eventually powerful

British supporters would be left in place via the BAR – British Accreditation Registry – as in, all newly graduated legal student having to “pass the BAR.”

This British organization, with subsidiaries in various countries, states, and cities, established the basis of continued control by the powerful European financial families, but in a secret, under-the-table way. Their long-range strategy led to an entanglement just before the Civil War between Abraham Lincoln, the American judicial system, the BAR, and the 13<sup>th</sup> Amendment.

I have been a fan of Abraham Lincoln since high school, believing him to be one of, if not the greatest of our Presidents, you know – Honest Abe and all that. However, some facts have come to light that challenge how virtuous he may actually have been. I am reluctant to judge him too harshly since we can't know exactly what he believed, thought, and wanted to see happen. But some cleverly hidden facts of history suggest he took part, maybe without realizing the ultimate and unintended consequences, in undoing our Republic. This has been a difficult concept for me, personally, to take in.

Lincoln tried four times, unsuccessfully, to run for President. There was a powerful political machine in operation. It wasn't until Lincoln agreed to join the BAR that the wealthy financial backers from New York, London, and Europe agreed to finance his campaign. Over seven million dollars was donated, and his name was plastered on nearly every train, silo, and building in the US. He was elected this time and became the first licensed member of the BAR to serve as President.

Lincoln then found himself personally and deeply indebted to those responsible for his successful election, a practice which unfortunately remains the norm in

Washington to this day. And thus Abraham Lincoln was the first of our Presidents to put his loyalty to his oath as a member of this foreign organization even above his oath to the American people. He had to repay the backing he received.

You see, a dilemma was therefore presented by Lincoln's successful election. The original wording in the 13<sup>th</sup> Amendment actually prohibited members of the BAR from serving in office. It originally stated, "If any citizen of the United States shall accept, claim, [or] receive, any title of nobility, or honor, or shall, without the consent of Congress, accept and retain any present, pension, office, or emolument of any kind whatever, from any emperor, king, prince, or foreign power, such person shall cease to be a citizen of the United States, and shall be incapable of holding any office of trust or profit under them, or either of them."

So in essence it says that no one can receive any title or honor or accept any office from any foreign power without forfeiting his citizenship of the US and thereby rendering himself ineligible for holding any office of trust and/or profiting from the relationship. Members of the BAR, *titled* "Esquire," were in direct violation of this Amendment. Lincoln, as a newly sworn-in member of the BAR, would not have been able to legally serve as President, nor would any other BAR members be able to hold an "office of trust," *having constitutionally forfeited his US citizenship*, according to the original 13<sup>th</sup> Amendment.

We almost lost this valuable written history about what happened with the original 13<sup>th</sup> Amendment. But, by a curious and providential "accident" in about 1983, researcher David Dodge inquired at a very old library in Belfast, Maine (established in 1798) if he could see their oldest copy of the Constitution. He and his colleague, Tom Dunn, were actually researching something else entirely, but

were blown away when presented with documentation of the existence of a 13<sup>th</sup> Amendment of which neither man had ever seen before. It was to have been ratified finally by Virginia in 1819. Controversy about this ratification has continued over the years since, because this documentation seems to have been removed from the Virginia archives.

Intrigued enough to want to prove whether or not it had been ratified, Dodge visited several libraries and other institutions around the country in at least 10 other states and territories that housed archived newspapers and publications, dating between 1822 and 1870. He found about 18 different mentions of the *ratified* 13<sup>th</sup> Amendment. This information was published this way for over 50 years!

Dodge sought out a publisher, Alfred Adask, who reviewed the documents he had gathered and wrote several articles, later compiling them into a book, *The Missing Amendment*. This was not a NY Times best-seller by any means, in fact very few copies were ever printed and sold. Evidently though, the information caught the attention of someone in the government of the US Inc (the corporation replacing the original Republic) and effort was made to squelch any more spreading of this knowledge. Further searching by Dodge several years later in about 1994 found that all these previous references in those 18 different archives had subsequently been expunged.

Why is it so hard to prove that this Amendment was slyly removed from the Constitution? With our comprehension of the actual events that occurred around the time of the Civil War, it is fairly easy to realize that owners of the soon-to-be-formed US Inc needed lawyers to continue their plan. It might be argued that this original 13<sup>th</sup> Amendment was an *extremely* important Amendment in running our



Republic, but not so much for the US Inc. Since the original Amendment was never lawfully repealed, it can be argued that it is still in effect today! Lincoln went on to free the slaves with the Emancipation Proclamation (September 22, 1862, and again on January 1, 1863). The *differently worded* 13<sup>th</sup> Amendment was proposed on January 31, 1865 and ratified on December 6, 1865, prohibiting slavery, unless one is in prison. On December 18, 1865, the *new* 13th Amendment loudly prohibiting and abolishing slavery, while quietly surrendering the intentions of our founding leaders, was proclaimed and adopted by Secretary of State Seward. This ratification served to effectively erase and replace the original, at least as far as the general population is concerned.

The clouded history on the *first* 13<sup>th</sup> Amendment and its erasure may never become totally clear to us today, but there is little doubt that our country has been greatly affected by what happened. It also might add a bit of polish back on the Lincoln persona/legacy to note that he was assassinated a few months before this new, changed 13<sup>th</sup> Amendment was ratified. Perhaps he had not been as cooperative with the powers-that-be than they had hoped?

Ever since this deed was done, unfortunately, bribery of legislators and the judiciary, a predominant number of whom are members of the BAR, used to further the positions of Special Interests, has become business as usual in Washington, with zero fear of any penalty or recourse. These special interest groups are a blight on a free Republic, with tentacles reaching into almost every

area of our lives. Today we find ourselves, the “little people,” at the mercy of huge conglomerates whose lobbying has allowed them to dictate and control our food-production systems, our entire medical and pharmaceutical system, our education system, our judicial and prison system, our transportation and public utilities systems, and our military – all for the purpose of gigantic profits *at the expense of We the People’s health, our minds, and our freedom.*

As the Civil War came to a close, Lincoln and his administration faced almost insurmountable expenses for rebuilding the torn, bloodied, and divided country. They negotiated a plan for an economic solution for America with the controlling financial families in London and Europe. Those same European families had lent America a sizeable sum after the Revolutionary War and were not happy with how slowly they had been repaid. This time they would require more collateral and be even more subtle in their methods.

### **The (Re)-enslavement of the American People**

Three years after changing the 13<sup>th</sup> Amendment, on July 9, 1868, the 14<sup>th</sup> Amendment was ratified. This states, in the first sentence, “All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are *citizens* of the United States and of the state wherein they reside.” (Emphasis mine)

Today we find that the use of this very clever wording placed all of us in servitude to what would very soon become the US Corporation. Prior to the ratification of the 14<sup>th</sup> Amendment, the population of the Republic were free-born American nationals, and were rarely referred to as *persons* or *citizens*. This blatantly obfuscating legalese language *paved the way for taking away our sovereignty* and

would soon make us “employees/slaves of the newly-formed US Corporation,” owned by the European Cabal.

The 14th Amendment made us citizens of the corporation. *Citi* = municipal and *zen* = servant. By being a citi-zen *of the corporation*, we are “public servants” or employees *of the corporation*. In the eyes of US Inc we are all merely vessels (identified by our all-caps names) and our government is a huge shipping company. Admiralty law governs everything having to do with contracts, corporations and commerce.

Think about what this means. *On December 6, 1865, the (new) 13<sup>th</sup> Amendment was ratified prohibiting slavery, and on July 9, 1868, less than three years later, the 14<sup>th</sup> Amendment was ratified making not just Africans slaves again, but **all** of us!*

By accepting (using our *tacit* consent) participation in this corporation, we are under this Admiralty law and are given the job – as employees – to be the Pursers of the vessel. The purser’s job is to pay all docking fees, taxes, etc. for the vessel. Not only are we citi-zens, but we are also pursers or persons. We the People with inalienable rights have become persons – those who have to pay the bills. The purser is a resident on the ship. When we apply for and obtain a Social Security Number we are further entrenched as a municipal servant of money-producing enterprise.

In *America’s First Freedom*, you may recall that I recounted many of the events that led up to the formation of the US Corporation as part of the story of

totalitarian control being taken by the European banking families. I will briefly summarize here.

In order to financially bail out our war-torn country, the savvy Cabal lenders required that they be granted the ten acres that is Washington, DC so they could virtually take over our government. The Organic Act of 1870 (signed in 1871) gave those foreign investors ten square miles of land on the Potomac and called it the DISTRICT OF COLUMBIA.

*This was and still is foreign soil, owned by foreign investors, and called THE UNITED STATES OF AMERICA [Inc.]. A new constitution was adopted (A CONSTITUTION OF THE UNITED STATES OF AMERICA). It sounded a lot like the original, organic Constitution for the united States of America, but it didn't reflect the will of We the People. Instead, it was a constitution that protected the wishes of the Corporation (US Inc). Important changes were made in this new Constitution to guarantee the owners of the corporation what they wanted—slaves.*

This foreign corporation was the third leg of a triumvirate to control the entire world devised by the European cabalistic investors. Britain was to be the financial leg; the US Inc was the police or military leg, and the Papacy in Rome was the “spiritual” leg.

Life proceeded through the balance of the 1800's and most Americans never knew what had taken place. Before the turn of the century, books showing the true history were burned and new ones written to tell the story as the powerful families wanted it taught, obscuring their complicity in the sequence of events.

In studying the industrial times of the late 1800's and early 1900's, you'll notice that the giants of industry who emerged as the most successful and powerful *had familial ties to the financial families of Europe*, who we'll henceforth just call the "Cabal." Names like Rockefeller and Carnegie come to mind, among many. Powerful industries – oil, railroads, steel, public utilities, textiles, medicine, and pharmaceuticals – were launched during this time. The leaders of these industries began to control and re-write history.

You might wonder why it is necessary to use the word "cabal." Merriam Webster defines it: *The meaning of Cabal is the contrived schemes of a group of persons secretly united in a plot (as to overturn the government); also: a group engaged in such schemes.* There is no word that fits better. These families have connived and schemed to engage in a plot to overthrow the real government of the United States, as in, We the People.

The health care industry is a single prime example of how the industrial giants took control. At the dawn of the twentieth century, natural plants and substances derived from them, were widely used for healing. The emerging medical profession began calling those remedies "alternative," which were subsequently ridiculed and eventually effectively strangled. Only medical schools that taught pharmaceuticals were funded. Funny how most drugs are produced using petroleum in the formulas, thus profiting the oil as well as the big pharmaceutical industries. Today the use of natural substances, like homeopathy, are often frowned upon, even banned, and the health care workers, who are labeled "witch doctors," are often criminalized.

The pieces were beginning to line up. **Changing the 13<sup>th</sup> Amendment** so members of the BAR could hold public office, **adding the 14<sup>th</sup> Amendment** that by sly

wording declares all American-born people to be employee/slaves of the Corporation, followed by the **establishment of the US Inc** were key factors in initiating the plot. More elements would soon be added to the mix, highlighted in bold.

Toward the last of the 1800's, the **industrial giants (with bloodline ties to the Cabal)** began to **take over** the country's most important **inventions, discoveries, and industries**. These included oil, electricity, medicine, education, communication, and the media, mostly newspapers and periodicals at that time. There are incredible stories of how these men (mostly) wrangled their way to monopolize the industries that would provide our most vital systems, products, and jobs. Many thousands of patented inventions that would benefit We The People have been *suppressed* by these same powers.

In the early 1900s a banking crisis and the clandestine meeting of bankers in Jekyll Island, Georgia, paved the way for **establishment of the Federal Reserve** on December 12, 1913 – not “federal” at all, but a company *privately-owned* by none other than these foreign investors. The Federal Reserve and the Secretary of Treasury could now control the boom-and-bust economic cycles that enable big bankers to periodically bankrupt and/or foreclose on properties of hundreds if not thousands of unfortunate American families and businesses. This was followed fairly quickly by the **formation of the IRS**, another *foreign-owned private company*. In 1913 the 16<sup>th</sup> Amendment said that the government (US Inc) could collect taxes and the IRS was tasked with enforcement of laws relating to alcohol sales due to the ending of Prohibition in 1933. It is of curious note that the 16<sup>th</sup> Amendment was never properly ratified by the required number of states.

In 1933 under FDR, the **confiscation of the American peoples' gold** and allodial property began a more aggressive action to bring the citizens of the corporation into compliance. It then *became illegal for American citizens to own precious metals and they could no longer exchange paper dollars for gold.*

In the early 1970's President Richard Nixon was faced with the uncomfortable situation of European bankers demanding gold in exchange for US paper money, taking a sizable chunk out of our gold reserves. After that, Nixon took the dollar completely off the gold standard, so that no one or government could ask to exchange paper for gold any more.

Without the link to gold, bank reserves (dollars) could be created by fiat – out of thin air. This led to a massive expansion in the money supply and debt. The power to exploit these debts and control the creation of new money is, and has been, the most powerful factor in today's economy. *Printing new dollars is the single biggest contributor to runaway inflation.*

Without gold backing a currency, the amount of economic mischief that governments can cause becomes virtually limitless. No social goal is too absurd, no war is too expensive, and no government insurance is too outrageous to pursue. Adjusted for debt and inflation, most of the population has only become gradually poorer, while a very few individuals have gotten much, much richer.

In 1902, an act of Congress formed the Bureau of Census to develop a standardized registration system for recording live births, and in the 1930's their system of **required Birth Certificates** was adopted. The first **Social Security numbers** were issued in 1936 and required of all workers, following FDR's Social Security Act,

passed into law August 14, 1935. By this time, *Americans could now be tracked, taxed, foreclosed, bankrupted, and their private information used in any number of nefarious ways.* Research shows how the birth certificates and social security numbers have been monetized and traded on the bond markets, earning trillions of dollars for the government.

Since 1871, our government has refused to “secure” our right to life, property, and personal freedom by persistently increasing our burden by regulations, prohibitions, mandates, unlawful taxes, and the pernicious devaluation of our money and health. Our Constitutional freedoms and our standard of living have been systematically, persistently, and progressively undermined. This hidden, criminal system has bastardized our Judicial System with Statutory Law, replacing the Common Law and the protections which it afforded us with the severe and brutal *Equity/Admiralty jurisdictions*, where the Constitution is of no protection.

Probably the clearest summary of what the Cabal sought was routed through the teachings and acceptance of socialism, and eventually communism. Marx and Engels succinctly state here the ten goals of the Communist Party in the *Communist Manifesto*. My thought is that the Cabal was likely behind the rise of the Russian and Bolshevik Revolutions, hence pernicious socialism and communism. It does cause one to wonder, doesn't it?

1. Abolition of property in land and application of all rents of land to public purposes.
2. A heavy progressive or graduated income tax.
3. Abolition of all rights of inheritance.
4. Confiscation of the property of all emigrants and rebels.



5. Centralization of credit in the hands of the state, by means of a national bank with State capital and an exclusive monopoly.
6. Centralization of the means of communication and transport in the hands of the State.
7. Extension of factories and instruments of production owned by the State; the bringing into cultivation of waste-lands, and the improvement of the soil generally in accordance with a common plan.
8. Equal liability of all to work. Establishment of industrial armies, especially for agriculture.
9. Combination of agriculture with manufacturing industries; gradual abolition of all the distinction between town and country by a more equable distribution of the populace over the country.
10. Free education for all children in public schools. Abolition of children's factory labor in its [then] present form. Combination of education with industrial production, etc.

It's disturbing to see how much of this philosophical plan has been adopted, accepted, and embraced by our teachers, politicians, and general population today. The educational system was one of the big areas where they wanted control. Leaders of the Cabal knew that if they could get control of the minds of the young people in a country, they would end up with obedient, loyal adults.

How does all this play out in America today, and what is meant by "slaves?" Let's attempt to weave it back together.

The corporation of 1871 was formed so the owners (the foreign banking investors or the Cabal) would have more collateral for the repayment of the money they

loaned to rebuild after the Civil War. *A corporation falls under the jurisdiction of Admiralty Law and, as such, contracts govern everything.* Admiralty Law governs everything to do with corporations, contracts, and those being contracted with. We'll soon bring to your attention a few of the many words rooted in nautical terms.

*Jurisdiction* means the words (diction) of the legal environment (juris). Jurisdiction is extremely important to fully grasp for maintaining our freedom. We must always know which jurisdiction we are operating within and carefully choose only the words that have power *within that jurisdiction.*

It is important in this context to have a basic comprehension of the *three jurisdictions* that we have in play today. It is expressed in LAW – L. A. W.

**LAND**—*Common Law*: Equity, Rights, Property, Superior Titles, Constitution & Treaties

**AIR**—*Ecclesiastical/Canon Law*: Trusts, Superior law, God-given, Familia, Soul

**WATER**—*Maritime/Admiralty*: Contracts, Commerce, Corporate, Statutory, By-Laws, Chattel

Much more can be said about each of these jurisdictions. Be aware that originally God gave mankind *dominion* over all three of what have become jurisdictions of law. In Genesis 1:28 it says, “. . . and have dominion over the fish of the sea [WATER], and over the fowl of the air [AIR], and over every living thing that moves upon the earth [LAND].”

The events that are recounted here explain how this beloved land came to be totally run by Admiralty Law. The Organic Act of 1871 placed us under the Law of the Sea as US Inc chattels owned by foreign European financial overlords. (Read more about how this came about in our first book, *America's First Freedom*.)

Since the establishment in 1871 of the US Inc placed us under the Admiralty law, is it just coincidence that the birth of a baby involves so many *nautical* words? When a pregnant woman is ready to give *birth*, she goes to a hospital, designated legally as *birthing* centers. She is admitted to the labor *ward*. The *dock*-tor *tugs* the baby through the *birth canal*. Coincidence doesn't quite seem to cover the similarities. (watch this video: <https://www.youtube.com/watch?v=pu6ly1lsj5k>)

Once the baby takes its first breath on American soil, it is a free, natural-born living child of God. This free status only lasts a short while, because the mother is very quickly required to sign the birth certificate. If you don't think there is enforcement involved, just try to deny signing. Parents simply cannot leave and take the baby home unless they have signed the certificate.

On this application for the birth certificate, the mother is often called the "informant." At this point the mother is so tired, maybe still groggy from drugs as well as euphoric over the new child, that she fails to notice what she is called where she signs.

An informant is one who gives forth information about another person or organization that might not be known otherwise. The mother is hereby informing, as a credible witness, the Corporation about the birth of another potential citizen. It is interesting to note the synonyms in the Merriam Webster dictionary for

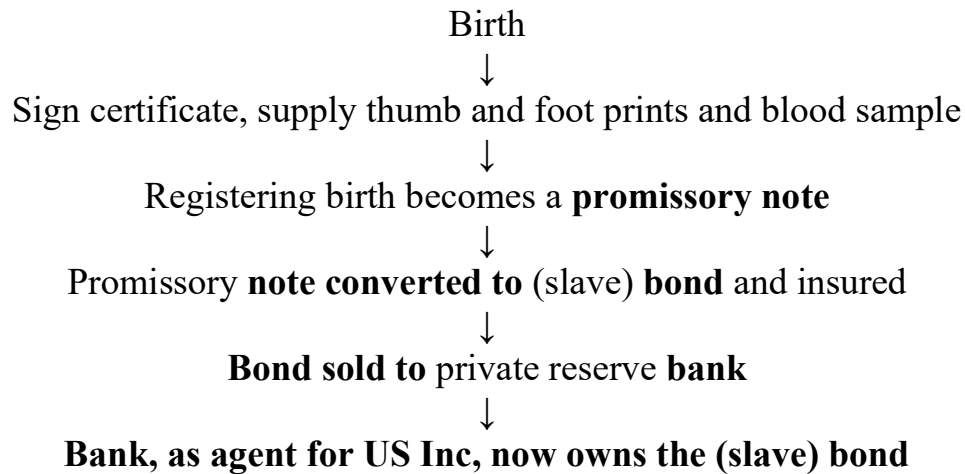
informant: “betrayed, canary, deep throat, fink, informer, nark, rat, rat fink, snitch, squealer, stool pigeon, stoolie, tattletale, whistle-blower.” Not very complimentary, is it?

*NOTE: When one goes to obtain the certificate of their birth today, in almost all states, one is not given a certified copy of the original “application” for a birth certificate that the mother (or father) signed. What is produced is a shorter version, with no signatures of the mother, father, doctor, or delivering assistant. It appears this has been done to further cloud the ability for us to see what actually happened. If you have an original copy with signatures, etc. you probably have a more valid document—often called the “long form” birth certificate.*

Along with signing as Informant, the mother gives an imprint of her thumb. They take an imprint of the newborn’s foot as well as a blood sample. The mother’s thumb print is her agreement and authorization. Duly certified and registered, the child is now *a ward of the state*. While these acts seem rather symbolic, they matter a great deal to controllers of the corporation.

When the US Inc refers to its citizens, all caps are used. Ever notice that everything to do with banking, contracts, law, government (US Inc) state your name in *all caps* i.e., JOHN HENRY DOE. Realize that this is a fiction – a fictitious vessel of a shipping company. This is part of the Admiralty Law we are under. As such this fictional person has citizenship (the “ship” at the end of a word is of course another nautical term).

So the process at and following a birth looks something like the following.



This owner/slave relationship has manifested most obviously in the American population's bondage to debt, primarily via mortgages and credit cards. How many other platforms have insidiously ensured our slavery?

*If one wanted to make slaves of a population, what steps would one take in order to bring that about?*

First, get control of the government and the industry. I think we have demonstrated how this control was planned and executed, step by step.

Through government regulations and industry, ruin the health of the people. Destroy the nutritional value of the food by depleting the soil, using poisonous and damaging chemical fertilizers and pesticides. Promote the use of chemical pharmacopeia and fail to mention or teach good nutritional practices. Teach health care providers that the use of alternative remedies is "primitive," "ineffective," and "quackery." Use all research funding to produce more pharmaceuticals so alternative remedies are never thoroughly researched. Don't publicize that the very

pharmaceuticals being prescribed to help us feel better, in *many cases actually further undermine health*. The disclaimers read at double speed at the end of drug commercials should make one's blood run cold.

Next, dumb down the population – via government oversight of education, make sure that children are taught, covertly, the principles of the *Communist Manifesto*. Teach them that the group is more important and valuable than the individual . . . that diversity is more valuable than individuality . . . that teamwork is more important than personal creativity and innovation . . . that studying math and science and engineering is passé . . . that hard work and good character are no longer a national values. . . that as long as it *sounds* good, it must *be* good, regardless of the long-term outcome. Teach them that violent protest is justified if the cause is worthy enough. Teach them which causes are the worthy ones and ridicule causes you don't want them to consider or embrace. Don't encourage them to think for themselves. Encourage them to grow up to be obedient worker bees who believe everything they hear or encounter through the media.

Encourage the government to undermine the flourishing of small businesses. Create chaotic situations that make it difficult to stay in business. (Political turmoil, pandemics, lockdowns, runaway inflation. . . .) Gradually, a bit at a time, remove individual liberties. (Gun laws, freedom of speech on social media platforms, mandated lockdowns, the Patriot Act, etc. . . .) Create and nurture division among the people, spark fear often and fan the flames so people can't think straight anymore. (Ever watch network news programs? Enough said.) In short, I would do pretty much exactly what has been done in our world today.

I want to leave this section with the blood-chilling words of Colonel Edward Mandel House, a close advisor to President Woodrow Wilson and a member of the European Cabal. *He revealed in a private meeting with President Wilson in the early 1900's that the bankers' plans were to enslave the American people.* His Vision was that the Presidency would perpetuate the slavery of Americans. By his and his cohorts' design we have been kept sick, confused, bankrupt, and insolvent.

*Very soon, every American will be required to register their biological property [that's you and me and our children] in a national system designed to keep track of the people and that will operate under the ancient system of pledging [the 14<sup>th</sup> Amendment]. By such methodology, we can compel people to submit to our agenda, which will affect our security as a charge back for our fiat paper currency.*

*Every American will be forced to register or suffer not being able to work and earn a living. They will be our chattels [property] and we will hold the security interest over them forever, by operation of the law-merchant under the scheme of secured transactions [loans]. Americans, by unknowingly or unwittingly delivering the bills of lading [Birth Certificate] to us will be rendered bankrupt and insolvent, secured by their pledges [to repay the loans].*

*They will be stripped of their rights and given a commercial value designed to make us a profit and they will be none the wiser, for not one man in a million could ever figure our plans and, if by accident one or two should figure it out, we have in our arsenal plausible deniability. After all, this is the only logical way to fund government,*

*by floating liens and debts to the registrants in the form of benefits and privileges.*

*This will inevitably reap us huge profits beyond our wildest expectations and leave every American a contributor to this fraud, which we will call 'Social Insurance' [Social Security, Medicare, farm subsidies, etc.]. Without realizing it, every American will unknowingly be our servant, however begrudgingly. The people will become helpless and without any hope for their redemption and we will employ the high office [presidency] of our dummy corporation [US Inc] to foment this plot against America.” [Our comments in brackets] –Colonel Edward Mandell House, (exact date unknown) to Woodrow Wilson (President 1913 to 1921) and found in Wilson's personal papers.*

## **ENTER: Mind Control and Conditioning**

How has the Cabal and the US Inc. managed to gain such control over the population and turn it (us) into veritable and unknowing slaves?

In case you haven't gotten the message by now, let me reiterate. We have been manipulated and lied to for most of our history. Our minds have been targeted from every possible direction to bend to the will of those who wish to control us, and there *are* those who wish to do just that. Our history has been rewritten with a hidden agenda to control, *not* to inform us of how we got to today. The truth has been camouflaged in propaganda. We have, in short, been brainwashed from



infancy into weakening or giving up our cognitive reasoning. We have been lulled into mental slumber. Brainwashing is essentially acquiring beliefs without critical thought. A belief is just a thought you continue to think—or are continually bombarded with (i.e., the media).

As one looks deeper into how *brainwashing* occurs, we find that the media uses that term, while psychologists refer to it as *conditioning*. Conditioning is something that occurs naturally as we grow, adapt, and find our place in society. It might or might not have a negative connotation.

“Conditioning is based upon associative reflexes that use words or symbols as triggers of installed automatic reactions. Conditioning, called brainwashing by the news agencies, is the production of reactions in the human organism through the use of associative reflexes.” (*The Manchurian Candidate*, Richard Condon)

Malicious brainwashing is covert, insidious, and sinister. From advertising to the MK Ultra experiments carried out by the CIA during the 1950’s and 60’s, much can be learned about how vulnerable we all are to having our minds “played with” by outside influences. Of course, once the shenanigans of MK Ultra began to come to light, the practice was immediately downplayed by claims that such techniques were no longer being used – as one will find in abundance on the Internet today – while in reality the mind conditioning use of pain versus pleasure is still covertly being used today. One has to look no further than the daily news, advertising, video games, and political broadcasting in case there is any doubt.

Consider how we are constantly conditioned by our television advertising, as just one example. Luscious-looking restaurant and fast food, gorgeous, svelte bodies,

and deliriously happy families give us many suggestions of what and where to eat, what to buy, where to go, and what our lives and bodies should be like. The ads teach us to compare ourselves to the ideals presented and to want the products that promise to remake us in that image. The more sinister implication is that one is inferior if not using these products. The advertised products rarely, if ever, deliver as promised! Have you noticed?

Advertising alone is bad enough, but consider the false, fake, and deliberate lies told through news channels and news personalities. The key to mind control is repetition, over and over and over again, with the deliberate use of pain versus pleasure. The promised pleasures are that one will be more beautiful, healthy, successful, “good,” happy, and acceptable when using the products or embracing the ideology presented, with the unspoken implication that if one does not buy or embrace, then the opposite will be true.

The way to overpower opposing viewpoints is to apply unbearable pain – ridicule, marginalization, criminalization, ostracism, silence. Use whatever means possible to make that viewpoint or set of facts appear to be the most stupid, inhuman perspective one could possibly have. Think about it for a while. Critical thinking requires *internal* thinking. You *do* have to turn off the TV to do internal thinking. Just saying.

Several years ago the movie *The Matrix* and its sequels were popular in theaters. One of the main threads in the story was that taking a *Red Pill* would enlighten one to the truth about reality, especially a truth that is difficult to accept or exposes disillusion. The other option was to take the blue/black pill, stay in the Matrix, and remain asleep. We are all given the same choice at this time of our history.

Most of the world has been lulled into a coma through media programming and social constructs. We find that people need to be gently awakened. Borrowing a term from this movie: you will most likely find that considering the subjects we have introduced in our books is like taking a *huge red pill*.

Psychologists today refer to *cognitive dissonance* as *the state of discomfort felt when two or more modes of thought contradict each other*. The clashing cognitions may include ideas, beliefs, or the knowledge that one has behaved in a certain way. The theory of cognitive dissonance proposes that people are averse to inconsistencies within their own minds. We will go to great lengths to adjust their thinking when our own thoughts, words, or behaviors seem to clash with each other. It causes great discomfort to be “unreconciled” within one’s self.

“When one learns new information that challenges a deeply held belief, for example, or acts in a way that seems to undercut a favorable *self-image*, that person may feel motivated to somehow resolve the negative feeling that results—to restore *cognitive consonance*. Though a person may not always resolve cognitive dissonance, the response to it may range from ignoring the source of it to changing one’s beliefs or behavior to eliminate the conflict.” (Emphasis mine) (Internet Review by *Psychology Today* Staff) We frequently deny or compartmentalize dissonant ideas or try to explain them away with little further thought.

Cognitive dissonance is one of the main reasons why most people are reluctant (or highly adverse) to any consideration that the world they thought they understood might actually be very different. I totally get that facing difficult questions is not easy. It definitely shakes up one’s sense of order and belonging. It frequently

makes conversations difficult with others who might not be so inclined. It may cause conflict and separation among family and friends. This is an inner journey. It is solitary. It can leave us feeling very much alone. It is a journey we *all* must eventually take, however, if we care enough to work to regain our freedoms and rights.

When we began Liberty Ministries International in 1979, I was dead serious about helping “right the ship.” Little did I know then that it actually *is a ship*, a vessel operating under Admiralty Law of the Sea. If you were part of our journey back then or read the book we started in the 1980’s and finished up last year, *America’s First Freedom*, you’ll know that we knew very little of the real behind-the-scenes story. We basically only knew things weren’t right and needed to change. We thought we knew a path to at least one viable solution, but we had no idea who or what we were actually dealing with and the power they actually held over us. We ended up squashed like little bugs under heavy jack boots!

“They” may have thought we had been totally eliminated. “They” may have thought we were no longer thinking or believing that answers and solutions might be available. “They” may have thought they had won. And they had—for a while, at least. Until COVID. Don’t tell me to stay at home for weeks on end. I’m going to start wondering and looking into what’s going on! And that’s what I did. These books about America’s First Freedom are the result.

Our country needs to wake up and return to control from the bottom up starting with We the People. We are the ones who elect, empower, and who should then hold accountable our State and its representatives. The Federal government should not be allowed to infest and infect every corner of our lives, like we find today.

We live in a marvelous time in history. It is high time to turn off the TV and start educating ourselves and standing up for our God-given, Constitutional rights. I know, it takes a lot of mental and emotional effort. I would like to just veg in front of the boob tube, but that's not what my life is about. I ran across a poignant quote the other day, and although I don't know to whom the credit should be given, I want to leave you with this challenging thought –

*Every generation has its purpose.*

*Ours is to reveal truth and reverse the brainwashing.*

### **Breaking the Hold of Brainwashing**

In this amazing time of human awakening (early 2023), the idea is being presented that it is often just one single fact or incident that can break the hold of mental conditioning. When this happens, an individual is no longer blinded by the illusion, and can begin to explore with volition.

**Media.** *All forms, including TV, radio, newspapers and periodicals, social media (all referred to as Main Street Media or MSM)*

- Are news sources truly dedicated to providing true, honest facts about situations, issues and events?
- Why do they use almost the exact same words and present almost identical ideas?
- Could it be true that they are purposefully trying to deceive and control us?
- Is it possible that I/we have been brainwashed by the TV, Social Media, educational system, etc.?
- Has the CIA influenced the media? If so, how long has it been going on? Why would they want to keep Americans from knowing the truth? What are sources of better reporting?
- What was/is Project Mockingbird, established by the CIA?
- Why do people who speak against the MSM narrative get silenced?

**Health Care.** *Doctors, hospitals, research labs, nutritionists, the AMA*

- Why are doctors taught only about pharmaceutical treatments in universities?
- Who owns the pharmaceutical companies and what is their agenda?
- Are doctors financially benefitted from or controlled by Pharma?
- Why was there a huge campaign to discredit and even ban certain substances that before were proven to improve health of people during the pandemic?

- Why are people reluctant to investigate ingredients in drugs and vaccines?
- Why do we just assume that the medical community is looking out for our best health and wellness without questioning their motives?
- Why does the population seem to be getting sicker and sicker?
- Why are homeopathic and herbal remedies not only ignored but ridiculed, derided, and mocked?
- Were hospitals, doctors, and medical communities incentivized and/or threatened to treat COVID-19 patients with only certain protocols?
- Why have some physicians had their license to practice threatened if they insisted on going against the prescribed practices?
- Would a doctor rarely give me advice about how to prevent or cure illness, and rather prescribe a medicine *first*? Why?
- If the medical community wants to promote or ban a substance where can one turn for help?

**Legal.** *Lawyers, attorneys, law enforcement that are licensed, regulated, and disciplined by governments and are part of the BAR*

- What is the BAR? Isn't it ultimately British? What does that mean for the attorney and what does it mean for the client?
- Why is it that judges will not allow a fully qualified lawyer to represent an individual – only fully licensed BAR attorneys?
- Most of us don't realize that the diction/jargon/words use in a court of law have different meanings from the common meaning of those same words. Do you know the difference?
- Why are so many politicians also BAR Attorneys?

- Why is Civics not taught in our schools today at all levels? When it is taught, why is it made so boring? Why don't our children and adults know more or care about the birth of our country?

**Financial.** *CPA's, Financial Advisors, and Bankers that are licensed and regulated by state governments*

- Because they are licensed and bonded by governments, is their first loyalty to the government (and their license) or to their clients?
- Why is so little taught about finances in grade and high schools?
- Why aren't personal financial strategies emphasized more to young adults?
- Why and when did it become illegal for Americans to own gold?
- How has taking the dollar off an asset-backed standard (gold, silver, etc.) affected our overall economy?

**Education.** *Public school teachers and professors from preschool through university levels who teach and promote a standardized syllabus*

- Why has the educational system become so politically polarized?
- Why is the Department of Education so threatened by school choice and parental involvement?
- How and why have the teacher's unions become so powerful?
- Why isn't the truth about our history as a nation being taught in schools?
- Why isn't history taught from an exciting and fun viewpoint instead of boring and uninteresting?
- Have you ever questioned things being taught in schools and universities? Did you form opinions? How were those opinions received?



- Why is there such a blatant political overtone to local school board meetings? Why would concerned and involved parents attending school board meetings be branded “domestic terrorists?”
- Why are our young people taught (brainwashed) to believe they must attend college and *get a degree* to be successful and get a good job?
- Why are so many current college graduates finding it difficult to land a good-paying job while burdened with years of student debt ahead of them?

**Religions.** *Preachers, ministers, priests, rabbis, especially members of the World Council of Churches and 501(c)3 organizations.*

- Why do people think they have to leave their spiritual education and belief system to *organized* religions?
- Have you ever questioned the *origins* of most churches?
- Have you ever questioned the teachings of a church or a church organization? How was it received? Did you change your beliefs based on the church’s reactions? Were you treated differently after? Are you still part of that organization?
- Have you ever been “kicked out” of a church or “disfellowshipped?” How did it make you feel?
- Have you ever looked into the inner workings or politics of most the main religions and denominations? What happens at the higher echelons? What did you find?
- Do you ever wonder what happens to the donations that devoted congregates give to a church?

**Governments, Corporations, Employers.** *Federal down through states, counties, and local towns and principalities who are part of the organized system (subsidiaries of the US Inc) and including businesses that also employ large numbers of the population*

- Why don't people research and study to educate themselves about our rights and responsibilities as freeborn Americans?
- Why do people continue to work somewhere they are unhappy?
- Why do people look to "authorities" to tell them what to do?
- Why did these institutions and corporations think they had the right to issue mandates during the recent pandemic?
- Why aren't we taught the truth about our birth certificates and the way we are made citizens of the US Corporation from birth (under the 14<sup>th</sup> Amendment)?

It takes courage to admit that perhaps you have been deceived. As you read down through this above set of questions, notice which ones piss you off, upset you the most, and push the most buttons. Which ones set off the most cognitive dissonance in you? Which ones resonate with something deep inside, sounding familiar, reasonable, or possible, or give you an "I-always-wondered-about-that" reaction?

Those who seek to control have a deep fear of their subjects waking up. They know that it only requires a small amount of questioning to cause a mass awakening. A snowball effect is created. Question beget questions.

Once the shell has cracked open, one is left wondering what the heck to do next. How can one begin to regain one's own personal thought processes and navigate

through the morass of information that is out there? What does one use for a compass? In the next section we will offer some tips on techniques and perspectives that can help form a framework or map by which to evaluate and steer.

### **Assemble a Box of *Life Tools***

Tools can be *anything that helps an individual to achieve a desired outcome or feeling*. Tools are personal assets and can be learned, polished, and honed, if approached with desire and inner honesty. Tools, or life skills, can take many forms, from a simple mantra to a carefully devised system of learning or performing to a technique that helps us refocus our attention. They are all about our *relationship with our own thinking: what holds us back and what moves us forward, in spite of what holds us back*.

Tools can help an individual regain clarity in a chaotic world. They might help one gain a more useful perspective of what is happening. They can even help one restore the thought process itself, if badly mauled and numbed by the system, and can help retrain our minds from the effects of mind conditioning.

What works for one person won't necessarily work for another, so it helps to be willing to experiment. Once aware of the existence of tools, or life hacks, a person's "tool antennae" activates and he or she will begin to notice more potential *tool ideas* to try out. It often has a snowball effect, gathering more and more ideas as it rolls along. And the more tools one carries in his or her toolbox, the more likely one is to arrive at positive outcomes in one's life.

A good tool must be fairly simple, repeatable, effective, and it must produce a positive result. What is “positive?” In this context, it is any result, no matter how seemingly insignificant, that helps nudge us in the direction we want to go.

*In context of this writing, the goal, the ultimate positive outcome, is to slash the bonds of brainwashing. To regain individual clarity of thought and the ability to discern what’s what in a stormy, confusing world. To awaken our sleeping minds.*

**Tool #1. Prayer and Meditation.** Prayer can be boiled down to its simplest concept: *talking to God or a higher power.* Meditation is *listening for an answer.*

Aside from ancient Eastern traditions, one of the earliest western books on meditation was the 1975 publication of *The Relaxation Response*, by Dr. Herbert Benson and Miriam Z. Klipper, and was followed by many more. And in 1982 and 1994, Dr. Larry Dossey published respectively *Space, Time & Medicine* and the *Power of Prayer* and followed these two books with many more. Dr. Dossey is a medical doctor who pursued an inquiry into whether there is any scientific proof of the effectiveness of prayer. Today there is a huge amount of information out there on both of these subjects, so we won’t go into it further here.

As with all journeys, this one begins with a first step and proceeds one step at a time, and every single step in the desired direction is valuable. Let’s take a look at some of the life tools that might help move us in the direction we want to go, starting with one that almost seems too simple to be useful.

**Tool #2. Inspiring and Life-Sustaining Literature.** We have found that it is vital to feed our Minds and Souls with nourishment found in the inspired and sacred books

written throughout history. We won't go into a long description, but will just encourage you to find those written words that are important for you and your growth. We aren't endorsing any philosophy, religion or organization over another. Only you know what is best for you. Now is the time in our society where we each need to use our own minds, hearts and intuition to find what works best for us. Here's a *very brief* list of important books we've found to feed our mind and soul. **Tool #3. Put It On the Shelf.** Around 1984, as a result of very distressing and severe interactions with the US Government and our organization Liberty Ministries, as recounted in both *America's First Freedom* and my personal *Memoir of Awakening*, I began very earnest and deep searching into who I was, what my life was about, and where I wanted to go next in life.

During this time I experienced serious *cognitive dissonance*, although I had never heard the term at that time. I was exploring many personal, religious, and spiritual concepts and beliefs that were far from many of my *previous* thoughts and beliefs.

One technique I found helpful was when a concept was presented that I was formerly in disagreement with, I envisioned a mental closet in my mind with a shelf for ideas that I wasn't ready to deal with. I would put that concept or teaching "on the shelf" and give myself permission to neither accept nor deny it at that moment. This technique allowed me to create the tiniest wedge in a mind that was for the most part refusing to open to possibility. Once a crack is formed, it can widen over time. It worked well for me, and I realized I had stumbled upon a tool I could use whenever I felt the need, and it has served me well over the years.

**Tool #4.** *The Emotional Guidance Scale*. One the most useful tools I have come across is from a book, "Ask and It Is Given," by Jerry and Esther Hicks. This scale shows the various emotional states in which we all find ourselves at any given time. The practicality of it is because we CAN change and improve our emotional state.

Our thoughts cause an emotional response in our mind and bodies, depending upon how much power is behind those thoughts. The thoughts then become beliefs if repeated many times. Those beliefs can then turn to actions, that may or may not have consequences. Given enough time and energy spent on a subject, it begins to manifest as something in our personal reality. This is a huge subject, and I am not doing it justice by any means. In short, if we can learn to learn to catch negative, hurtful, and disempowering thoughts early and use the Emotional Guidance Scale to improve our emotional state, much better personal reality will be created.

It is important to be honest with yourself about where you are on this chart, based upon *how you feel* emotionally at the moment. It doesn't matter how you wish you felt or how you think you should feel. Just ascertain how you actually do feel on any given subject you are pondering. Ignore the ignorant blabbering about emotions being a weakness.

Once you know where you are right now, you can – by deliberately reaching for better thoughts and feelings – inch your way up the scale to feeling a little better, and then yet a little better. You don't need to try to get all the way up to the very top emotions. Just try to get a bit higher, or maybe even above the mid-point.

Understand that going directly from despair to joy is way too big a jump for a single step. A person gets to the top of a building by taking one step after another after another. This is an easy path for moving into more positive emotional states from wherever one begins, and takes only a few minutes.

In the example below we show how to use the scale to incrementally raise your emotional state by climbing one do-able step at a time, using inner dialogue to get there. The corresponding emotions from the chart are listed in parentheses.

*I find myself feeling **fear, despair, depression (22)** – at the bottom of the chart. The Pits! It is possible to decide to feel the emotion just above, one little step. **Insecurity (21)**. Where do I feel insecure? Why? Am I **jealous (20)** of someone or something? It is so **unjust**. . . I am so **defensive (19)**.*



*In fact, I feel I'd like to exact **revenge (18)**. I am so **angry (17)**. I've been taken advantage of so badly. It is so **discouraging (16)**. I feel so disrespected and want to **blame (15)** someone. It makes me **worried and nervous (14)**. I am so **uncertain** about my life and **doubtful (13)** about what might happen.*

*I am really **disappointed (12)**. In fact I feel **overwhelmed, confused**. There is so much for me to do. I am **stressed out (11)**! I am **frustrated** and really **irritated**. I am totally **impatient (10)** with it all. It seems like **nothing is happening** and I am **pessimistic (9)** about my life. I just want to **let it all go**. I'm **bored** and all I want to do is **give up the struggle (8)**.*

*I want to feel **grateful (7)** for what's happening, but I doubt so much that it get any better. I guess I can just **hope (6)** for a better outcome. All really is well when I think about it. I feel a glimmer of **optimism** and **anticipate (5)** what might be.*

*You know, I have noticed that **things always seem to work out** in the end. I have some **positive expectation (4)** about where my life is headed. I'm actually **excited** about what might unfold. I am **eager** to see the changes. I am really **enthusiastic (3)** about my future.*

*I have **passions** that I look forward to and I am **confident (2)** about moving forward! I am so **joyful** knowing the **freedom and love** that are available to me! I feel **empowered** in planning my next steps! I **appreciate (1)** my life and all those that are in it!*

I keep this chart close at hand (a copy even in my phone), so that I can “run the scale” at a moment’s notice and not stay stuck in any negative state that I really don’t desire. I can quickly continue to move up, feeling each emotion and acknowledging that it does feel a little better, and/or a little more empowering, than the one before.

*By diligently monitoring and adjusting one’s emotional state, one can regain control of one’s actions and ultimately of one’s life!*

**Tool #5. Trajectory.** In college, my sister (and my very valued editor) took a class on mental health and learned a valuable lesson she has frequently used over the many years since her college days. Her professor drew a horizontal line on the chalk board, then stopped the chalk and drew an X at that point on the straight line. He explained that we meet points of decision in life – “life” indicated by moving along the horizontal line and “POD” (point of decision) indicated by the chalk stopping on its journey with an X.

At these junctures, he explained that we can either make a decision to step upward (desirable) or downward (undesirable). In this case, the decision was desirable, so he drew a step up where the chalk continued on a horizontal journey until it met the next POD. It looked a lot like a step up on a sidewalk. At every POD we have

the opportunity to go either up or down. This is exactly where the Emotional Guidance Scale can fit in as a tool as well.

Each decision has an effect on our journey. If the majority of decisions are up, even if interspersed with some down choices, one's life is moving in a positive *Trajectory*. If the majority of decisions are downward, one's life is moving in a negative *Trajectory*. It's very similar to looking at the movement of a particular stock on the NASDAQ – the Trajectory is either flat, bullish, or bearish.

So, if one took the trajectory all the way to the top of the stairway, what would one find there? What *is* the ultimate goal, anyway? This is where we find *who we really are in our deepest selves*, no matter what we have done in our lives. *This is our core being, and reuniting with it is humanity's ultimate journey in life*. Love. Harmony. Compassion. Joy. Laughter. Peace. Abundance. Empowerment. Freedom. Spinoffs at this end are wisdom, understanding, success, calmness, exuberance, passion, clarity, dominion, purpose, sovereignty, vitality, expansion, nurturing, creativity, self-worth. . . .

And at the bottom end? What's down there? Fear. Despair. Division. Suspicion. Powerlessness. Depression. Neglect. Slavery. Insecurity. Jealousy. Spinoffs are hopelessness, disease, greed, bigotry, failure, violence and cruelty, dominance, worthlessness, confusion, desensitization to violence, gullibility, closed mindset, ignorance, lack, addiction, dullness. . . .

The perspective provided by Trajectory can have many very broad applications in life. Will an action be moving one closer to one's desired outcome, or farther away from it? Will eating this cinnamon roll take me closer to or farther away from my

goal of losing weight and improving my health? Will saying something kind in this situation take me closer or farther away from the peaceful world I desire to inhabit? This invaluable tool can provide a compass that helps with navigating through life, a means of evaluating information and situations as they arise, as opposed to just drifting aimlessly.

Keep in mind that *at every single juncture we come to, no matter how far up or down the scale we may currently find ourselves, we are given a precious opportunity to change the direction of our trajectory!* What an incredibly powerful gift! (Refer also to The Emotional Guidance Scale at the end of this book.)

**Tool #6. Contemplation.** Contemplation is less formal than meditation. It is a technique that can act like a magnet, attracting to one's attention more bits of information relevant to the subject being contemplated. One can contemplate an idea for a few days or several years. The topic can be anything, but it is wise to utilize the trajectory tool in choosing it – a topic that takes one's trajectory in a more upward direction.

The method of Contemplation is very simply to form a question – possibly one about a topic you want to understand better or maybe an idea that has been causing discomfort for a while – and to let that question waft through one's mind a few times a day. Writing the question on a sticky note and putting it on the bathroom mirror and/or on the door of the refrigerator can help bring one's attention back to the topic. Then go about the day. Don't try to "answer the question" or overthink the topic. Just observe what comes up. That's pretty much it.

As time goes on, notice what bits of information relevant to the question begin to emerge. The magnet of contemplation will attract more and more information that will eventually give at least a degree of clarity on the question. Just because it is so simple, don't make the mistake of underestimating its power.

One good place to look for a topic to contemplate is on our "shelf." You know, the one upon which we place ideas we just can't get our minds around, ideas we don't know whether are true or not, ideas we just don't know quite what to do with? Is there a question or idea or issue up there that keeps nagging at you, yelling for attention? That one is a great place to start using your tool of contemplation. I'll bet this writing has brought up lots of items for your shelf.

The goal is to arrive at one's *own* conclusions, not just parroting what one has heard from someone else. When you have weighed an idea in your heart of hearts, striving for the most personal integrity and honesty you can muster, then no one can take that concept away from you. It is yours. You may later find your conclusion is too limiting and adjust it accordingly. That's fine. It is not cast in stone; it is cast upon your mind and your heart. It is flexible when it needs to change or grow, but change or growth *that is directed by you* and you alone, for your own upward mobility.

Here are a few suggestions for Contemplation. Try to find your own. These will help you get the idea.

- Can any of this stuff about our country/history possibly be true?
- Do the medical and food production industries have my best interest at heart?

- Do those within the present US government really care about the wellbeing and prosperity of the population?
- Is my child getting the best education possible in our school? Is he or she being taught both sides to the stories, or are most stories slanted in one direction? Is the core curriculum solid? Is she being encouraged to think for herself? Do the teachers care about developing strong, independent individuals?
- Is there a point of balance in respecting diversity? Is it possible to go overboard in our accommodations of those who are different? What is too little? Too much?
- What are my personal values in life?
- How can I get ahold of my (fill in the blank) before it destroys my life?
- Do I have a purpose in being here? What is it?
- What does nurturing mean?
- How can I/we help heal the deep divide in this country? Have I been making it worse? How?
- How healthy is the food I am feeding my body and more importantly, my *mind*?
- Is it possible we have been systematically brainwashed as a nation?

**Tool #7. Digestion.** What? That's right. Digestion. As humans, we contain many levels of digestion, not just food in the physical body. *The process is the same,* whether we're talking about our physical, mental, emotional, or spiritual bodies. *We intake something, run it through the system, glean what is useful, and discard the rest.* This applies to all our four bodies. Remember the old programming saying: garbage in, garbage out? Well, the *quality* of what we feed our physical

body, our minds, our emotions, and our spirits matters. Endeavor to get a balanced, good quality diet on all levels. What does that mean?

We know what junk food is, and for the most part we understand that it isn't good for us. But what is the equivalent of mental junk food? Is what is programmed on broadcast channels healthy or junk? In my opinion, the huge majority is purely junk, designed to keep us sitting still, glued with glassy eyes to the show, to be frequently interrupted by advertisements (or mind conditioning) begging us to buy into whatever they are selling. Playing violent games on our gaming devices for hours every day? Watching inane comedies that aren't even funny? Do we only watch one channel, all day, every day? (How can that possibly help expand one's outlook?) Whatever we feed our minds, that is mental food – and it has a nutritional value, just like physical food does. It can help nurture our upward mental journey if we ingest a good *variety* of mental foods that help enrich our mental activity. This is the same on all levels. Go to [www.libertyministries.com/](http://www.libertyministries.com/)

What is emotional food? It is the nurturing or lack thereof we have from the relationships in our lives. Do those around us encourage us to stretch and grow and become the best we can be? Do they appreciate our efforts, even when we fail? Do they believe in us? Or do they insult, ridicule, and/or judge us at every turn?

Spiritual food? Do we align with teachers and teachings who nurture and encourage the best in us, or those who judge us? Or are we maybe on a spiritual starvation diet, ignoring entirely the needs of our spiritual selves? Food on this level needs to foster exploration, growth, and the evolution of our concepts of who we are and what we can do. Staying stuck in one mindset is staying stuck as the world evolves around us.

I had a brother-in-law (now deceased) who was always interested in someone with new ideas. He would jump in and learn all he could about it, until he found something with which he disagreed. At that point he would chuck the entire concept out the window. How could any of it be right if part of it wasn't? He didn't understand the value of the perspective of *Digestion*. Not every part of the food is usable by the body, so do we vomit it all out? No, the body in its wisdom only keeps the useful parts and passes out or eliminates what's left.

- *Get a wide variety of input from the most positive (nourishing) sources available.*
- *Understand that you can keep only the parts that are most useful to you, and slough off what's not.*
- *Don't fall into the trap of throwing the baby out with the bathwater like my brother-in-law.*

**Tool #8.** *Examine Core beliefs.* Beliefs are very powerful, for good or ill. They are ideas we hold with emotion, and they color all of our thoughts and actions. Of themselves they aren't "good or evil," but in the perspective of Trajectory, some of them are far more beneficial in helping us move upward. The most important thing to remember about Beliefs is that they are not cast in stone. We created them, whether we knew it or not, and as such we can deliberately un-create them. Beliefs are merely thoughts we have *repetitively* thought. Guard your thoughts! By replacing the old thoughts we held with emotion with new thoughts we hold with emotion, *our Beliefs can be changed!*



In seeking to re-educate myself, I've come to see that many deep and closely-held beliefs and "facts" have been so altered, twisted, covered up, and hidden that it's hard to know *what* to believe. Most of what we learned in school, particularly if it was public school systems, is tainted or outright false. I am willing to have an open mind, like a parachute, to consider that someone might have had an agenda for what they were/are teaching. I am open to never simply accepting gullibly, but rather saying, "well, ok, maybe it's possible. . . ."

There are some institutions, beliefs, and teachings that I have long held in esteem and as personal beliefs that I am now choosing to examine with fresh perspective. If you read my *Memoir*, you'll remember how little I've bought into the "mainstream" all through my life.

The first things I examined is *what is a belief?* How do we get our beliefs? What effect on our lives do they have? I got a great definition of belief from a wonderful teacher of mine. She stated that a belief was just a thought you keep thinking. I've already stated this a few times.

Using that as a guide, I realized that my beliefs formed throughout my life once a thought was introduced. This could have been one of my own thoughts, or more commonly, it was a thought someone else shared. As I mulled those thoughts around in my mind, some seemed to stick, or resonate, and I thought about them more. I didn't really examine from what source they came. The thought just became more and more familiar and then seemed to me like a *Belief*. Adding an emotional charge, it became a *Core Belief* and presto—I had built my own belief system.

### Useful Beliefs –

- I am worthy because I am a child of the Divine Creator
- Everything I need I already contain inside me
- I can find my way through any confusion and turmoil
- Everything always works out for me in the long run
- My parents did the best they could with what they had available
- I am loved and I can love
- The universe is a benevolent place
- I have an amazing ability to think for myself
- This, too, shall pass
- I hold my best interest at heart
- I can't control what others around me think, do, or believe
- I can control what I think, do, and believe
- All people, as God's children, are good at the core

### Less useful Beliefs –

- I am not talented, smart, or valuable
- Nothing I do turns out well
- I can't do anything right
- The universe is out to get me
- Nobody cares about me
- My parents didn't love me
- My siblings, parents, teachers (fill in the blanks) picked on me
- I am a victim
- I can't make one whit of difference in the world
- There is no use in even trying

- I need to get everything I can, no matter the cost to those around me

**Tool #9.** Group Discussion. On this journey of discovering tools for making sense of our world, talking with like-minded individuals can be very beneficial. *The trick is to choose those to talk with who are in agreement with our most positive values and beliefs.* Some like to call this your Master Mind group. This is an opportunity to express new ideas and bounce them off a more tolerant audience, to hear new ways of looking at things, to add new tools to your toolbox.

It also might provide a forum for keeping an eye on public servants and discussing how well we're being governed, as intended in the First Amendment Right to peaceful assembly.

**Tool #10.** Resonance. Resonance is a deeply personal tool. It is that little spark of recognition of something one had maybe been trying to express and couldn't quite articulate. It is often, but not always, accompanied by goose-bumps. After a period of contemplation, one might notice a deep satisfaction with something that suddenly occurs to us in a way we hadn't thought of before. Some call this an "aha" moment. It often feels like getting to a bottom line. Sometimes it is simply a nudge from our deepest, inner being to look further in a particular direction.

Never discount the message of Resonance. It won't lead one astray. It can help immensely in the midst of trying to find clarity among a bunch of what feels like fog. It can provide a deeper level of knowing that one is on the right track.

**Tool #11.** Preponderance of Evidence. This is something I have had to consider in my quest to allow an open mind to explore. We sometimes hesitate to dig in to

something in fear it might fool us into believing something that isn't true. But in an effort to dig out the Preponderance of Evidence, we will definitely gain more clarity. This tool isn't as spiritual as Resonance, but it can help one look at the set of facts, as best as can be determined, and see what the Preponderance of Evidence suggests. The answer might agree with popular opinion, and it might not.

In using a tool to help one discriminate and arrive at a likely conclusion, one can know that the conclusion was based on *personal effort* and discernment rather than just "it's what she said." Also be sure to test all "evidence" against your own Inner Knowing as to its veracity and value.

**Tool #12.** *Follow the money.* This tool is much like Preponderance of Evidence, and the two are often tied together. Some, or most, of that preponderance is likely to be related to money. In trying to sort out the facts from the fictions, Following the Money is often the key to arrive at a well-thought-out conclusion. It is more likely that the money motivation is at the base of an idea than not.

Let's say we are contemplating the health care system in America and whether it is looking out for my most vital self. We have been disturbed by the idea that the system might not be wanting the best of health for us, and are reluctant to consider the possibility. One way to wade in would be to think about the money trail. Who stands to gain the most income from our being sick, and who stands to gain the most from our being in radiant health? Who stood to make the most money from COVID-19 and the subsequent series of poorly-tested vaccines? Is it even possible that our array of drugs, with all their scary side effects, were *designed* to keep us coming back for more drugs to deal with the fallout?? Following the money can

potentially give us an entirely new perspective on what might be going on behind our backs.

**Tool #13. Research.** This is a tool meant to help guide one in the direction of what is true. Unfortunately, there is way more information out there that is *not* true, particularly in the subjects related to this writing, than *are* true. That is because the real story is one that the powers that be don't want to be made public knowledge. If everyone knew what they had been up to, the game would be over.

Research is one way to wade through the items being presented as fact. From there, we have to employ our complete arsenal of life tools to help us determine what is most likely to be true. That's why this tool is listed last.

The search engines and websites you use are critical. The Deep State/Cabal have gotten control of most of them. They use that influence to continue to mislead and provide disinformation. Avoid: Google, and other "main" browsers and search engines. Avoid: Wikipedia; Snoops, etc. The playing field changes almost daily, but I've found *less* "controlled" search engines to be DuckDuckGo, Brave, Qwant, Freespoke, and others found by searching "uncensored search engines" on one of these. I have found Brave and Qwant to be my two favorites for both my computer and my phone, at least at this point in time (Jan 2023).

This is where I would suggest beginning one's research. We urge you to research this type of information just long enough to satisfy yourself that you've been duped and lied to by our politicians and the press for many years. 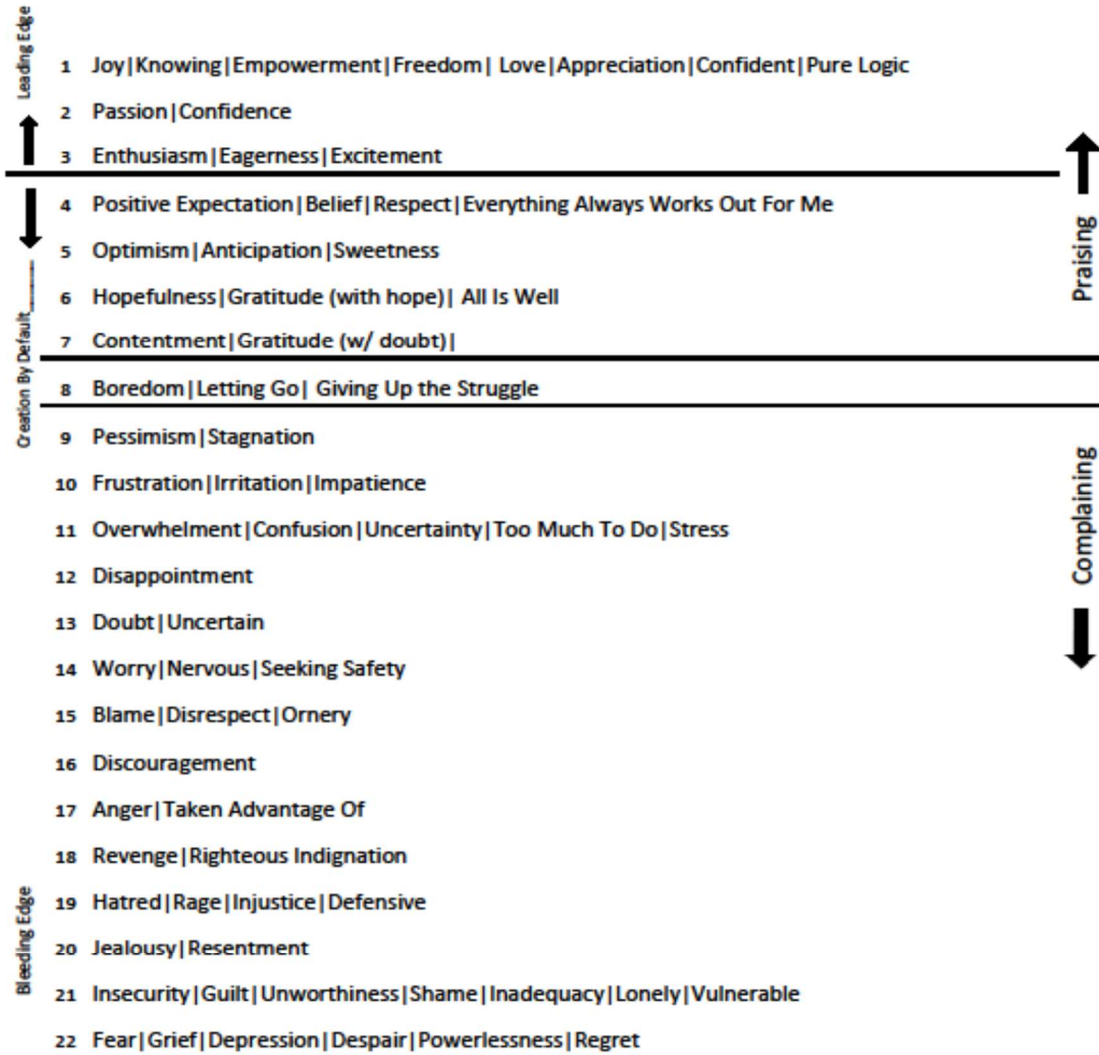

### WHO IS THE CABAL

### HOW WILL WE PAY FOR NESARA/GESARA?

Historical Background: Summary of RV History: Dr. Dan Ecklund, Author

The funding for establishing the "Golden Age" in the US and the entire world, including introducing MedBeds, and thousands of humanitarian projects all over the world, originates in South America 500 years ago. And in Mexico. The Inca and Aztec silver and gold mines were taken by the Spanish Conquistadores. The precious metals were shipped across the Atlantic to Europe. Since most of the banking for Europe was in Venice, that is where much of the silver and gold arrived.

Marco Polo and his brother were Venetian traders, who had followed the spice trade routes to China. Asia had three or four things coveted by Europe: Tea, Silk, Spices, and Porcelain were at the top of the list. Much of the Inca Silver made its way to China and the Spice Islands (Indonesia) in exchange for these three items. And much of the wealth of Europe ended up in China and SE Asia.

But the Asians did not want anything from Europe, so the silver just stayed there. Much of it was maintained in underground vaults, in Indonesia, Philippines, and other countries.

Eventually, the English figured out how they could get some of their silver back. There was a plant (the opium poppy or *papaver somniferum*) in Afghanistan which was very popular. The English took that plant and had it grown by their slaves in India, and then sent to China. The Chinese did not want this plant, as they knew what it would do to their people. But the Europeans insisted. This was in about

1850 and the plant gave its name to the conflict that resulted: The Opium Wars. The Europeans refused any regulation of their opium trade, and the Chinese population was decimated by opium addiction.

With the Chinese nation (the Ching Dynasty) crippled by addiction, Japan settled into northern China. They sponsored bandits and brigands to assist the Japanese government to take over much of China: Bandits and thieves would steal from the people, the people would cry out to their leaders, but nothing happened. The Japanese invaders offered to help the people to drive out the bandits, and their help was accepted. The bandits moved onward, and the cycle was repeated. Eventually, the Imperial Ching Dynasty government was pretty much driven out of existence, and in 1911 a Honolulu-trained physician led a movement to take over the Dynasty and establish the Nationalist Chinese Government.

### **The Elders**

The Nationalist Government fought against the Japanese occupiers in the Sino-Japanese War of 1935. The Japanese took much of the treasure they had stolen from China, and hid it in the vaults mentioned above. They established a guardian tribe over at least some of the vaults, who continue guarding the vaults to this day. The vaults full of gold, silver and other treasure extend for miles in several countries. You can learn more about the Japanese vaults in the book *Gold Warriors*.

[NOTE: My husband and I had a personal friend who was allowed to visit several of these caves. He personally saw the stacks of gold bars with his own eyes and relayed his experience to us. This same friend mysteriously died several years later. Maybe he saw or knew too much. He often talked about the corruption of President George H.W. Bush.]

When Japan was defeated, the royalty of several Asian nations claimed ownership of the vaults. We call them the "Chinese Elders", though many of them were not Chinese. These Elders devoted their treasure to finance the prosperity and advancement of the world. But how would they convert a bunch of ancient gold and silver into modern money?

In 1945, there was a world monetary conference in Bretton Woods, New Hampshire. A plan was agreed to by the nations to use the US Dollar as the world

reserve currency. All other currencies would be pegged, or based on, their relative value vs the US Dollar. The Elders agreed to let their funds be used as collateral for all of the paper money currencies.

In other words, a dollar bill could be exchanged for a dollar's worth of silver or gold, and the nation's treasury would hold a certain amount of these metals. Further, gold and silver would be kept in the vaults in SE Asia, as Collateral Accounts, and would provide the gold for the commerce of nations.

In exchange for the use of their gold as collateral, each nation which issued paper notes was supposed to pay a fee of 4% of the value of the notes to the Elders, each year. Even today, pallets of uncut sheets of \$100 USD bills and 500 Euros are collected in the vaults. And this money was to be used to fund humanitarian and infrastructure projects in the various nations.

Due to the Cabal's control of the global money supply, this "rent" on the collateral stopped, and what was paid was controlled so that it could not be spent. For example, US \$10,000 notes were used for a period of time, but then the Cabal said that these were illegal to use, and anyone who had them was imprisoned. The same thing happened with special Indonesian notes, and Swiss franc notes. The humanitarian projects were not done, and the infrastructure projects were done BY THE CABAL, and that is how they raised a lot of their money to control the world. Think of JP Morgan and Vanderbilt being the railroad barons.

For 60 years, the Elders tried to find a way to inject their wealth into the world financial system, but the Cabal made regulations which disallowed them from using it. For example, if gold were not registered with a Cabal mint, it could not be used in world trade. And they would not accept gold into the mint if it did not have a modern chain of custody.

### **The RV (Revaluation of global currencies)**

Eventually, a plan was created to inject the wealth of the Collateral Accounts into the world economy. It would be through a revaluation of certain depressed currencies, as well as payment on some bonds. This is known as The RV (Revaluation), as it focused on the Iraqi Dinar (See below). It was also called the GCR for Global Currency Reset. The Cabal came up with their own version, called the Great Reset, which was a scheme to take control of ALL ASSETS, which

would then be leased back to the former owners, who would have nothing. A system of total control would result.

### **The IRAQI DINAR REVALUATION (RV)**

In 1983, the currency of Iraq, called the Dinar, was valued at about \$3.85 dollars. More valuable than the US dollar. But the leader of Iraq, Saddam Hussein, decided that he would sell his country's oil using his own currency, not just the US Dollar, as was mandated by the Cabal.

As a result, the US created a war against Iraq, based on a fictional attack on the Twin Towers in New York by Saudi Arabian agents. Afghanistan and Iraq were attacked—what sense does that make?

As a tactic for disempowering Iraq, the US caused their currency to be devalued down to 1185 dinars PER DOLLAR, a decrease of about 3000 times. Ever since, Iraq has been not only damaged by the war, but it remains impoverished as its currency, which was more valuable than the US Dollar, became almost worthless.

A similar devaluation happened to the Kuwaiti Dinar at the same time. It went from about \$3 down to 15 cents, during that war. But after the war, it revalued to a value of \$9 each, before settling about \$5. Those who were in the know (Cabal agents and US military generals, mostly) bought Kuwaiti currency at \$0.15, and watched it rise to \$9, whereupon they sold it and pocketed the profit.

Well, the same plan was created for the Iraqi Dinar or IQD. Once again, it was supposed to be a secret known only to the Cabal and high US Military officials. President George W. Bush claimed at the beginning of the war that the war would cost the US nothing. They had this plan right from the beginning.

A few US oil contractors working in Iraq found out about the plan, and told their friends. The plan and opportunity was shared at some churches, and then spread throughout the new, fledgling internet and using a multi-level marketing structure. Several million people have bought Iraqi Dinars, to benefit from the expected revaluation.



In early 2023, the Central Bank of Iraq stated they have revalued their currency. It appears that the world-wide RV will follow closely. Those who bought a million dinars for a few dollars will have multiple millions shortly.

Several other related and unrelated currencies, like the Vietnamese, Iranian, Indonesian, and Indian currencies, are also about to revalue at the same time. Those who have learned about these revaluations will benefit greatly.

### **ZIMBABWE BOND NOTES**

In addition to the currencies due to RV/Revalue, there is another method for funding humanitarian and infrastructure projects.

At one time, the largest denominated currency note was the 100 trillion Zimbabwe dollar note. The result of years of hyperinflation of Zimbabwe (formerly Rhodesia's) dollar, the "Zim" notes were "demonetized" or removed from the national currency system over 10 years ago, and but remained popular among currency collectors as supposedly the largest monetary note in circulation. As it turns out there are many much larger Zim notes which were never circulated, such as the "Google dollar" note with 100 zeros.

Since the 100 Trillion-dollar Zim note is not currently circulated, it cannot be revalued. However, it is being treated as a bond, and a means of inserting value from the "Chinese Elders'" Global Collateral Accounts into the new global financial system is being created. Expected returns from the Zim redemption range from 11-40 dollars per million Zim dollars (11-40 million dollars per 100T Zim note) according to many, up to unlimited value for Zim notes according to Ron Giles.

According to Simon Parkes, Ron Giles was used as a designer of the new QFS Quantum Financial System, a new financial system not controlled by the Global Cabal. Ron Giles says in his essays that there will be no specific value applied to Zim notes when they are "redeemed" at "redemption centers". Instead, Giles says that the 100 T Zim notes can be worth any amount, depending on the cost of the humanitarian or infrastructure projects intended by the Zim bond owner. Furthermore, Giles says that even counterfeit Zim bond/notes will be limitlessly redeemed, according to the intention of the bearer, since the intention is for the notes to be a means of funding projects, not for making anyone wealthy! And

Giles claims that a kind of artificial intelligence, or a divine being of some sort, will embody the QFS hardware, in order to read the worthiness and intention of the bearer. Let's just sit back and see what happens.

## **QFS**

Simon Parkes and his Connecting Consciousness members will probably be aware of one description of the Quantum Financial System provided by Charlie Ward. He claims to get his information directly from highly placed financial players he has known for years. Ron Giles has another description, which is often disputed. You can explore that by searching for "Ron Giles QFS Love Won". This following description is mostly from Zim redeemers information combined with those two.

The Quantum Financial System appears to be mostly a money system, using gold and silver-backed currencies traded and transmitted along a private secure blockchain-enabled system, which is somewhat decentralized, and exists on satellites as well as possibly ground stations on Earth. It will possibly use digital money and/or the cryptocurrency XRP, from the Ripple money system, to transmit value.

The QFS exists outside of national financial or banking software systems such as SWIFT, CIIPS, FEDWIRE, Western Union, or others. All currencies transmitted by QFS will be INDIVIDUALLY backed by numbered bars of gold, silver or platinum. In this way, the OWNERSHIP of a particular bar (or coin) is transferred from one account to another. The physical metal does not need to move, but remains in the vault.

Consider the QFS as a big river of monetary value, flowing freely past many houses and factories. Anytime a village or town needs water/value, the local water department can remove water from the river, process it, and make it available to the town.

The water department is thus acting as a bank, essentially providing value received from the QFS to the townspeople.

And people who have value recorded in QFS accounts can send some of that value to another account, or into the bank/water system in a particular town. I have been told that QFS account holders can send currency to another existing QFS account,

to their own bank account to be further transmitted to bank account holders, or the QFS account holder can create a secondary QFS account in someone else's name, and send money into that new account.

## **NEW MONEY**

The USD or Fiat US Dollar, backed by nothing, is dying. It will soon be gone, and will be replaced by a USN or New US Note. Once called Rainbow Currency, as that is how it is referred to in the NESARA law. These new notes are very colorful, still showing the faces of presidents, but in a portrait format rather than a horizontal format. They should be available shortly. The currencies which revalue, and the Zim notes which are redeemed, will be paid in the new USN. The old fiat USD will be used for a while, but will continue to shrink in value.

Other new currencies are going to appear. One is the Gold Dinar, which will be used as the reference currency by the Middle East/North Africa area. Muammar Gaddafi, a leader much loved by his people, was murdered on order of the Cabal when he attempted to 1) provide an unlimited sea of water in the Sahara Desert, and 2) create a gold-backed Gold Dinar to be used in the Middle East and North Africa. The Cabal did not want anyone using currency other than the ones they created and lent to the governments at interest.

China is creating a gold backed Yuan or Renminbi. The main revaluing currency in Asia is the Vietnam Dong. It will revalue similarly to the Iraqi Dinar.

Europe will abandon the Euro, and individual countries will once again use national currencies. But these currencies will be gold-backed, like the USN and Gold Dinar and Gold Yuan. Their value will be tied to the value of a bar of gold, and that will not vary so much, as it does now.

## **FUNDING MEDBEDS**

I hope that you now have an idea of the source of money possible for MedBeds (healing centers). Miles-long tunnels full of gold and silver will serve to fund humanitarian and infrastructure to create a whole new world.

This completed a triumvirate of three city-states to control the entire world. Wording began to show up in 1894 with the Tariff Act of 1894 as the earliest statutory (statutes are written and governed by the US Corp.) reference to tax exemption for certain organizations.

Then the Revenue Act of 1913 established the income tax system with exemption for certain organizations. Of course, upon deep research and the testimony of many IRS agents, it is suspect that the Revenue Act of 1913 (the 16<sup>th</sup> Amendment) was ever properly ratified. That is another whole research project.

It wasn't until 1954 upon the establishment of the modern tax code, that section 501(c) for exempt organizations came into play. It is to be noted that *churches*, specifically, were not required to apply for this exempt status (that is according to legal counsel we received in 1979). In practical terms it has become a *requirement* if a church wants to have donations given to them be not-to-be-challenged as deductible for the giver. You can read more about our drama with this in our first book, [\*American's First Freedom\*](#).

In this time of the reign of tyranny by the IRS, individuals are basically required to prove that any church they donate to (or other tax-exempt organization for that matter) have been granted the 501(c)3 exempt status by the IRS. Otherwise, the individual may not be allowed the deduction on their personal tax return.

This is a powerful hammer that the IRS wields over many struggling young churches. There are 14 guidelines that IRS uses to determine if this organization meets their standards and requirements. We cover those guidelines in our book. We concluded it is not possible to follow God and also the IRS. Churches who have jumped through this hoop, in our opinion at this point in time, have capitulated and surrendered to the control of the Cabal.

Councils of Churches—including the World Council and the National Council—were formed around the time of WWII. With very lofty and humanitarian sounding goals, these organizations had the Cabal at their roots trying to organize and unify churches under a banner that could be controlled by them.

In our opinion, any church that has 501(c)3 status or belongs to any of the world's Council of Churches, is part of the cabalistic system and not one that we would have any affiliation with or endorsement of.

**ADDITIONAL NOTE:**

Under the original Republic, faith and religion were detailed under the 1<sup>st</sup> Amendment, which in part protects against the government making a law that would prohibit the free exercise of one's belief.

Under the Corporation (US Inc.), the government wants to control religious institutions by having them come under their jurisdiction as corporations e.g., under Section 501(c)(3) under Title 26 of the Internal Revenue Code (US Code) prevents the clergy, pastors, ministers, etc. from having any political influence on its members or the public in general.

The corporate government regulates what is to be said and not to be said. It is important to note that when the churches entered into agreement to incorporate with the Federal Corporation that they then unknowingly agreed with Priest Rule, which is Papal Rule and is in alignment with the Defendants/Enemies.
